### **KS3 Residential 2026 – Osmington Bay**

Dear Parents/Guardians,

I am pleased to announce plans for a residential school Activity trip to Dorset on **Wednesday 1<sup>st</sup> July 2026 – Friday 3<sup>rd</sup> July 2026** for our students in Year 7 & 8.

This will be a 2-night, 3-day activity-packed visit, involving a wide variety of outdoor challenges and tasks, ranging from raft-building and kayaking to having a go on the zip-wire or the giant trapeze.

The trip is being organised in conjunction with PGL, whose activity centres are licensed in the UK by the Adventure Activities Licensing Authority (AALA).

The total cost of the trip is £462 and includes accommodation, transport, food, activity sessions, evening entertainment and travel insurance.

This amount can be paid over 6 monthly instalments of £77.00 between October 2025 and March 2026, although the first of these will be an initial deposit to secure the places with PGL due by Friday 17<sup>th</sup> October 2025.

Payments will be due as outlined below:-

- Deposit of £77.00 by 17<sup>th</sup> October 2025
- 2<sup>nd</sup> Payment of £77.00 by 3<sup>rd</sup> November 2025
- 3<sup>rd</sup> Payment of £77.00 by 1<sup>st</sup> December 2025
- 4<sup>th</sup> Payment of £77.00 by 5<sup>th</sup> January 2026
- 5<sup>th</sup> Payment of £77.00 by 2<sup>nd</sup> February 2026
- Final Payment of £77.00 by 2<sup>nd</sup> March 2026

You will be able to sign up and make your deposit payment on Arbor from 6pm on Friday 3<sup>rd</sup> October 2025. Sign up will close on Friday 17th October 2025, at 6pm.
